BIOGRAPHICAL NOTE

George, Earl Macartney, was born in Ireland on May 14, 1737. He was the only son of George Macartney of Lissanoure. At the age of thirteen, George matriculated at Trinity College, Dublin, from whence he graduated in 1759. He entered as a student at the Middle Temple, but not seeking a call to the bar, he travelled on the Continent for some time.

On his return, having been a great friend of the Holland family, he was appointed envoy-extraordinary to St. Petersburg, to conclude a commercial treaty with the Empress Catherine, which he accomplished to the satisfaction of both Fox and Burke. Before leaving on his mission he was knighted (October 19, 1764). In 1768 he married a daughter of Lord Bute, and in the following year was appointed chief secretary for Ireland. In 1775 he became Governor of the Caribbean Islands, and was captured by the French when Granada was attacked in 1779.

In 1780 he was appointed by the East India Company governor of Fort St. George, in Madras, at the time of the Mahratta War, and remained in India until 1786, when he resigned in consequence of his views not being upheld at home.

In 1792, owing to the injustice done to the English subjects by the Chinese, he was sent as Ambassador to Pekin, and embarked on board the "Lion" on September 26. This embassy, the most noted of its kind in history, was splendidly equipped. To lend more dignity to the embassy, Lord Macartney was created an earl before embarking on this voyage. Accompanied by a large guard of militia, by men of science, secretaries, etc., everything possible was done to make the embassy worthy of the cause.

On his arrival, the Earl was most graciously received. The embassy collected much important and valuable information relating to conditions in China, trade, customs and usages, etc. In so far that they did not succeed in securing permission to have a British minister resident in China, which was one of the prime objects, the embassy has been termed by some a failure. But in the light of what was accomplished, there is no justice in such a stigma.

In 1795 he was sent to Verona on a confidential mission to Louis XVIII. He subsequently became governor of the newly captured colony of the Cape of Good Hope. He died in 1806.

HISTORICAL NOTE REGARDING THE MANUSCRIPTS

Several years ago Mr. Charles W. Wason purchased, for his Collection of Books and Manuscripts relating to China and the Chinese, the complete set of original manuscripts comprising the Official Documents and Reports of Lord Macartney's Embassy to China, 1793 to 1794, in the original 21 large folio volumes as gathered together and bound up by Lord Macartney. These were secured from the celebrated collection of manuscripts formed by Sir Thomas Phillipps, Bart. His collection was the most valuable and important ever gathered together. Among other manuscripts relating to Lord Macartney's mission, purchased from the Phillipps collection, and now included in this collection, are Lord Macartney's Commonplace Book, kept during his Embassy in China, and the Original Manuscripts Journal and Log of H.M.S. "Lion" including the records of the voyage kept by Sir Erasmus Gower. The Lion being the ship upon which Lord Macartney's Embassy sailed to China, and which remained in the Yellow Sea and the Canton River during the years of his embassy.

The present collection of manuscripts forms a most important and valuable supplement to the above. These manuscripts were never sold but remained in the hands of the Macartney family until purchased for Mr. Wason's collection. They passed directly from the Macartney family to this collection. At the death of Lord Macartney, they passed to Mr. C.G. Macartney of Lissancour Castle, Killagan County, Antrim, Ireland. During July, 1915 they were offered for sale by Mr. C.G. Macartney and purchased for this collection.

At the time of their purchase they were tied up in the original bundles with red tape. They have been carefully sorted out, arranged, classified, indexed, and bound to preserve them, and to make them available for use, and accessible to the historian or investigator.
