Horatio Seymour, 1810-1886. Papers, 1741-1920.

The papers in this collection are concerned principally with the land holdings and business dealings of the Seymour family and the related Bleecker and Tibbits families. The early papers relate largely to the history and disposal of lands, especially in the counties of Albany, Herkimer and Oneida, acquired during the colonial period by the Bleecker family (Barent, Rutger, and John Rutger). The papers include deeds and leases, surveys by John Lawyer and others, statements <sup>of</sup> expenses incurred in connection with Cosby's Manor and Ellice Lands (administered first by John R. Bleecker and later by Benjamin Tibbits). Early accounts are with Philip Schuyler, financier and land holder. There are papers and documents connected with the division and settlement of the estate of John R. Bleecker, including will, inventories of lands and property, and accounts with Horatio Seymour.

Horatio Seymour had a great interest in the development of the New York State Canal system, and there are a number of papers concerned with the draining of the Canaseraga Swamp Lands in connection with the building of a lateral canal. There is an account book giving use of the canal in the year 1826-27. A suit involving shipment of wheat on the canal in the 1840's (Alden Lee vs. Robert Fero), in which Crocker and Seymour represented, the defendants gives interesting insights into canal trade.

The development of business in the city of Utica appears throughout the whole collection from the time of the Bleecker and Lansing holdings to the period after the Civil War. There are some papers concerning milling at Oriskany, iron manufacturing, banking (Farmer's Loan and Trust Co.), and the Utica Insurance Company, in which Alexander B. Johnson and Henry Green were both greatly involved. One letter book contains copies of letters mailed by these two men on insurance company business. There are also a number of letters from Henry Green, business agent, to the Seymour brothers on other business matters.

Horatio Seymour. Papers.

In 1853, a corporation was formed to build the Saint Mary's Ship Canal connecting Lake Superior with the lower Great Lakes. John F. Seymour and Erastus Corning were directly involved in this venture. This file of papers is very full, giving information on the formation of the corporation, the agreement with the Michigan state government, problems involved in building the canal, etc. Letters from the agent, Charles T. Harvey, are very interesting and detailed touching on technical problems, labor problems, etc. Upon completion the canal was turned over to Michigan, and the corporation was paid in timber and mineral lands on the northern peninsula. A new corporation was formed to develop these lands, Saint Mary's Canal Mineral Company, of which John F. Seymour and Benjamin Tibbits were directors. Closely connected with this latter company was the Fox and Wisconsin Improvement Co.
