Augustus Low of the committee on legislation, and John R. Curry and Robert Whyland of the forest taxation committee; mimeographed copies of papers read by Sharon J. Mauhs, C. J. Yops, S. J. Hyde, E. W. Littlefield, and other representatives from the N.Y.S. Conservation Department on forest fire and forest pest damage and control, the operation of the Forest Practice Act, salvage projects, and other subjects; speeches made by N.Y.S. Senator Wheeler Milmoë on the activities of the Joint Legislative Committee on Natural Resources with Special Reference to the Forest Preserve, by Arthur S. Hopkins on the Northeastern Interstate Forest Fire Protection Commission, by Harold D. Ellis on the American Forest Products Industries, Inc., by Maurice K. 
