Letters (1877-1881) of Jennie McGraw Fiske to Judge Boardman of Ithaca, executor of her father's estate, relating primarily to John McGraw's estate and to her European travels, but also containing references to Cornell University and Andrew D. Write; one letter (Aug. 2, 1880) from George R. Williams discussing the accounts of the Fiske estate; a few letters and statements in English and Icelandic (June 8, 15, July 12, 1905, Feb. 10, 1906, July 14, 1909 and undated) concerning a provision in the will of Willard Fiske bequeathing money to the residents of Grimsby island off Iceland; receipts for personal property of the J. M. Fiske estate turned over to Boardman (1890); one volume containing inventory of art objects of the estate given to Cornell University in 1883 and returned to Willard Fiske in 1890, their sale prices, and court records of Yates County (1881); accounting statements made by Boardman in connection with the estate (1881-1885).

Judge Boardman's letter, written prior to his departure for Europe, to his son-in-law, George R. Williams, giving him instructions on handling certain investments Boardman, Williams' father [Josiah B. Williams], and Cornell University intended to make in Macon County, Illinois bonds, on the management of the John McGraw estate and Miss McGraw's affairs, including payments to William Henry Miller as architect of themansion she was having built in Ithaca, and on other financial affairs, Ithaca, March 27, 1880; also, the power-of-attorney given to Williams at the time, March 25th. 3 pcs.
