Daniel Alden Reed received an LL.B. from Cornell University in 1898 and became a lawyer in Dunkirk, New York, 1900-1903; attorney for New York State Excise Department, 1903-1907; football coach at Cornell University, 1909-1918; member, Special Food Conservation Mission to France and England, 1918-1919; member of Congress, 43rd New York District, 1919-1959; member House Ways and Means Committee, 1933-1959, chairman, 1953-1954, chairman of Subcommittee on Social Security, 1948; and delegate to Interparliamentary Union, 1938, 1948-1950, 1952.

January 19, 1954 Letter from Eisenhower to Reed (both in Washington, D.C.), thanking him for lending his name to the Administration's plan for extension of the OASI (probably, Old Age & Survivors' Insurance name not spelled out) and the formula to better integrate the program with Old Age Assistance.
- 6. March 18, 1954 Letter from Eisenhower to Reed (both in Washington, D.C.), "I tried to get you on the telephone this afternoon to congratulate you on your magnificent victory. You really had what it took. It makes me feel good to have such associates."
- 7. March 19, 1954 Carbon copy of letter from Reed to Eisenhower in Washington, D.C., replying to Eisenhower's letter of the preceding day (see above) and commenting that "if it had not been for your stirring appeal to the citizens of this country the result would have been otherwise I am sure."
- 8. June 2, 1954 Letter from Eisenhower to Reed (both in Washington, D.C.), thanking him for his successful efforts in regard to the Social Security program.
- 9. June 3, 1954 Carbon copy of letter from Reed to Eisenhower in Washington, D.C., thanking him for his "most gracious note" of the preceding day (see above).
- 10. July 15, 1954 (marked "personal and confidential") Letter from Eisenhower to Reed (both in Washington, D.C.), expressing the hope that Reed would be the "field general" for retaining in a tax bill the House provisions encouraging foreign investment by American business.

August 23, 1954 Letter from Eisenhower in Denver, Colorado, to Reed in Washington, D.C., expressing appreciation for Reed's "splendid cooperation" during the long session of the 83rd Congress and stating that the massive record of that Congress was the result of Reed's "personal efforts and forceful leadership."

October 31, 1954 Telegram from Eisenhower in Washington, D.C., to Reed in Dunkirk, N.Y., expressing his hope that the people of Reed's state, by their votes for him and other Republican Congressional candidates, would do their part to assure another Republican-led Congress. Also, telegram of congratulation on Reed's reflection, Nov. 6, 1954.
- 13. December 29, 1954 Carbon copy of a letter from Reed to Eisenhower, explaining that a statement released to the press by Reed the previous day was intended solely to express admiration for the manner in which Eisenhower (assisted by Secretary Dulles) had conducted the nation's foreign affairs; because the press had given coverage only to that portion of Reed's statement expressing reservations as to foreign trade policy, a copy of the statement was included with the letter.
- 14. January 10, 1955 Letter from Eisenhower to Reed (both in Washington, D.C.), thanking him for sending him a bottle of Irgapyrin and stating that he would consult with Howard Snyder [the President's physician] about it.

- 15. January 11, 1955 Letter from Eisenhower to Reed (both in Washington, D.C.), informing him that Howard Snyder had told him that Irgapyrin had an American equivalent, Butazoladin, which Eisenhower had been taking for about a week; Reed's tablets were being returned with profound thanks.

A mimeographed copy of the statement (December 28, 1954) is included with the letter.
- 6. February 11, 1959: Carbon copy of letter from Reed to Secretary of State Dulles at Walter Reed Hospital in Washington, D.C., extending best wishes for a successful operation and speedy recovery and remarking that "You are still my outstanding Secretary of State." [This letter was written just a few days before Reed's death.]
