The Lyman Stuart Papers consist of letter of several families - all the letters being scattered over a long period of time and written to and from many different persons. The letters from 1820 to 1840 concern the families of Rev. and Mrs. Aaron Lane (Waterloo, N.Y.), Barnhardt (Palmyra, N.Y.), Handerson (Wolcott, N.Y.), Henry Dean (New Lebanon, N.Y.), and Luke Blodgett (Webster, Mich.). All of these tell of everyday occurrences and problems, of births, deaths, and marriages. Clothing, illness, cures and remedies, prices, agriculture, etc. are also referred to. Later letters in this collection are a small group of Civil War letters from James and Charles Carver of Savannah, N.Y. From these comes a picture of the common soldier's lot, and his opinions and descriptions of battles and minor skirmishes. Still later letters written by D. Watson Davis, show life in the 1870's in the Montana and Dakota Territories and Western Canada. Davis deals particularly with the merchandising practices and goods offered by J. G. Baker, with whom he is employed.
