NEWMAN, JARED TREMAN ('75), 1855-1937. Papers, [1803-1937]-1953; 2 vols., 150 items. Attorney, Ithaca city attorney, 1893-1896, and mayor, 1907-1908; Cornell University Trustee, 1895-1903, 1907-1933; bank official. These additional papers of Jared T. Newman and his family [see 1958-1962 Report] include a letter (Port-au-Prince, 1803) from Joseph Lafayette LePine, the maternal grandfather of Newman's mother, Cornelia Ann Treman (Mrs. Isaac Harmon Newman), to his mother-in-law, Margaret Kearney, concerning his removal with his motherless children from France to Haiti and referring to the troubled conditions on the island; three letters and an accounting in French (Paris, 1843) concerning an indemnity France paid to LePine's daughter, Newman's grandmother, Anna Marie Louise (LePine) Paddock Treman (Mrs. Jared Treman), for losses her family suffered during the slave revolts in Haiti, and reminiscences (4 pp. typescript carbon, 1889) written by Adrian(n)a Leonora Treman King, Newman's aunt, concerning her mother's life after her grandfather Joseph's disappearance and presumed death in Haiti. Also, Newman's own correspondence and related papers, including a letter (1875) from a friend and fraternity brother, Wilmot Moses Smith ('74), concerning Newman's recent graduation from Cornell and his plans for the future, draft of a letter (1891) to William Ozmun Wyckoff, expressing his interest in the Republican nomination for the judgeship of Tompkins County and assessing his chances of receiving it; a letter (1892) from Eugene Frayer ('76), written the spring that Charles Kendall Adams' resigned as President of Cornell University, telling Newman that he was misquoted by a New York Tribune reporter whose news story gave the impression that he had compared Adams with Andrew D. White to the detriment of the latter and giving him his candid opinion of Adams and his administration; his report as Alumni Trustee (1898) and a copy of a letter (1925) to Professor Floyd K. Richtmyer, outlining his views on the objectives of a proposed school of religion at Cornell; an abstract of correspondence (1922-1936) between Newman and Charles H. Blood concerning the construction of gas and water lines and other matters relating to the development of Cayuga Heights and the minutes of the organization meeting of the Cayuga Heights Land Corporation (1928); a memoranda book and business and personal correspondence; MS. and printed matter concerning his interest in the Ithaca

Presbyterian Church and in religious affairs in general; and biographical sketches and related newspaper clippings. Papers of Newman's son, Charles H. Newman ('13) include his certificate of clerkship in his father's law office (1913); copies of letters of introduction to Parisians and Americans in Paris that Professor Othon Guerlac wrote for his use while he was with the Field Artillery, American Expeditionary Forces, and other correspondence, reports, and memoranda (1917-1925) concerning his service in World War I and his veterans' claims; letters of condolence and memorial resolutions received on the death of his father (1937); and correspondence with Gerald C. Williams, Frederick R. Stevens, and others (1938, 1953) concerning biographical sketches of his father. Tompkins County. (2157)

Attorney, Ithaca city attorney, 1893-1896, and mayor, 1907-1908; Cornell University Trustee, 1895-1903, 1907-1933; bank official. Correspondence, legal documents, reports, accounts, blueprints, maps, clippings, and printed matter dealing primarily with the interest of Mr. Newman and Charles H. Blood in the development of Cayuga Heights, but including similar papers which pertain to Renwick Heights and Bryant Park. Also, letters and related papers concerning his law practice; banking institutions in Ithaca and elsewhere; investments in gas and electric, oil, street railway, and other securities; real estate in South Dakota, Illinois, and Florida; other business concerns; the expansion and promotion of the New York State Barge Canal System; the affairs of Cascadilla School; alumni activities of the Class of '75, the Cornell University Christian Association and Cornell United Religious Work, his appointment as special lecturer in the Law School (1897-1898), and his terms of service as a Trustee; and his support of the Ithaca Presbyterian Church; also, one scrapbook and correspondence with family and friends. 5. January 14, 1919 - Concerning the deed to the Cayuga Heights lot.
6. August 22, 1923 - Discusses the replacement of some red pine trees that had been destroyed.

1. August 8, 1919 - Concerning things to be done to a house before she moves in.
