Agriculturist, public servant. Maurice C. Burritt (Cornell University Class 1908, M.S. 1910) was vice-director and later director of Extension, Cornell University (1917-1924); a member of the board of the Western New York Fruit Growers Cooperative Packing Association (1925+); director and fiscal officer of the Grange League Federation (1924-1928); a member of the Agricultural Advisory Commissions of Governors Roosevelt and Lehman; member, New York State Public Service Commission (1930-1949); president (1932-1939) and director (1932-1956) of the State Bank of Hilton and an official in other banks and loans associations; leader in the Farm Bureau Federation; Alumni Trustee (1934-1941); author of APPLE GROWING and THE COUNTY AGENT AND THE FARM BUREAU; and owner and operator of Beechwood Farm, Hilton, New York.

Summary: Correspondence, reports, budgets, and other materials relating to the Food Supply Commission; letters to Howard E. Babcock, general manager of G.L.F. and others; minutes of meetings, 1924-30. Correspondence and related papers pertaining to activities and policies of the AMERICAN AGRICULTURIST, Cornell University Arboretum, Farm Credit Administration, Federal Land Bank of Springfield, Federal Farm Board, Gannett newspapers, New York State Department of Agriculture, New York State College of Agriculture at Cornell University, New York State Horticultural Society, and various other agencies and institutions which he was a member. Correspondence with publishers; notes for and copies of Burritt's speeches and articles on public utilities and rural electrification, 1930s, and other subjects. Also, diaries, 1897-1956 and 1959, journals, scrapbooks, and other items on his travels in the British Isles, Alaska, Mexico, India, and elsewhere; letters from his daughter, Helen Burritt Latif, describing her experiences travelling or teaching in Australia and India, 1935-1937; scrapbooks of articles and editorials he wrote; memoranda books; detailed accounts of Beechwood Farm, with related land papers; and crop production cost analyses including cost analyses for the Office of Farm Management, U.S.D.A., 1909-1914.

Also, personal and family accounts; farm and household accounts of Burritt's parents, Stephen Day Burritt and Anna Chase Burritt; genealogical data on the Burritt, Phelps, and Barber families; records of School District #9, Parma, 1890-1948; Beechwood Farm photo album and other photographs; blueprints; manuscript and printed material relating to the history of Hilton and of agriculture in New York State; and other printed items. Correspondents include Howard E. Babcock, Liberty Hyde Bailey, Edmund Ezra Day, Thomas E. Dewey, Edward R. Eastman, Livingston Farrand, Frank E. Gannett, Halsey B. Knapp, Carl E. Ladd, Herbert H. Farm Credit Administration (Nov. 1933-Mar. 1936, 4 pcs.)

Now that the emergency is over, we are devoting all of our time and energy in trying to build a sound foundation for a permanent cooperative system." Adv. Com. appointed 1928, of which B was a member, and asking him and the rest of the commission to continue during FDR's next term of office (Dec. 12, 1930); a copy of B's letter to FDR (July 19, 1932) in answer to a letter from Mayor Rolland Marvin, Syracuse (copy incl., July 11, 1932) about the elimination of NY Central grade crossings in that city; a carbon copy of a letter from B to FDR (Nov. 9, 1932) congratulating him upon his election to the Presidency; a carbon copy of a letter from B to FDR (Jan. 6, 1933) containing an unsolicited recommendation of Morgenthau for Secretary of Agriculture, stressing his experience in agriculture and his important role in NYS agriculture, which B termed "the best organized" and considered as having "the finest cooperation among all of its agricultural agencies and farm leaders of any state in the Union."
